## COMMENT:

#1 = THE SUBMITTED SAMPLE COMPLIED WITH THE THERMAL TEST, COMBUSTIBILITY, STABILITY, COOKING GRID AND DYNAMIC TEST PER CLAUSE 5.2 TO 5.6.

THE GRID WAS STAPLED TO THE FUEL COMPARTMENT ALONG THE RIM OF THE FOLDED EDGE, MAKING IT UNABLE TO OPEN WITHOUT DAMAGING THE FUEL COMPARTMENT AND THUS AVOID ANY ADDITION OF FUEL UNDER NORMAL USE.

HOWEVER, EXTINGUISHING MATERIAL OR INCOMBUSTABLE PACKAGING WAS MISSING IN THE SINGLE USE BARBECUE. PER THE STANDARD, THEY SHALL BE PROVIDED TO AVOID RISKS OF FIRE AFTER USING.
