Subject: 1174 Charcoal Ignition Product Approval (Product Reference No. C117).

Dear Mr. Ho,

The South Coast Air Quality Management District (SCAQMD) is pleased to inform you that your company's "Instant Light" charcoal briquettes have been approved. The SCAQMD reference number, C117, is required to be displayed on the label of the approved product in the following format: "This product complies with South Coast Air Quality Management District Rule 1174, Ref. C117".

Being approved, the self-contained ignition product may be distributed and sold, as a complying product, in the South Coast Air Basin. The basis for the approval is as follows:

1. Evaluation and approval of the certification testing conducted by Horizon Air Measurement Services and reported in document B21-001-FR that was submitted by your company demonstrating VOC emissions resulting from the ignition of the self-lighting briquette were less than 0.02 pounds of VOC per start when tested according to the Rule 1174 SCAQMD protocol.

This approval is subject to revocation should the SCAQMD find that:

1. The formulation of the named product differs from the original SCAQMD approved product formulations.
2. Random testing of samples of the named product, taken from points of sale or distribution within areas subject to SCAQMD regulations, demonstrates that the product does not comply with the emission limits of Rule 1174 when tested according to the SCAQMD protocol.

- 3 The lighting instructions do not follow the product use as outlined in the test and label submitted for evaluation.


